I. ELECTION OF OFFICERS OF ISSC FOR TERM 2000-2004

ISSC Circular No. 94 of May 24, 1999, discussed the procedure for election of officers of the Subcommittee for the term 2000-2004, and included a Nominating Form for the members to express their choice for Chairman and Vice Chairman for the next term of office. The procedure called for the closing of the nominating period on June 9, 1999.

Only 8 responses with the following nominations were received:

For Chairman:

Alberto Riccardi 6 votes

For Vice Chairman:

Maria Bianca Cita 6 votes

Single votes were received for Chlupac, Larsson, Salvador and Wardlaw.

The procedure for election of ISSC officers calls next for asking all those receiving two or more votes (equivalent to nomination and seconds) if they accept their nomination, and if they will be willing to serve if elected. That I have done.

Even though is only one candidate for Chairman and one for Vice Chairman, it is desirable to proceed with the election of officers for the term 2000-2004. Attached to this circular, therefore, is the Ballot Form with the names of the nominees and spaces for write-in candidates. Each member of the Subcommittee is requested to vote for the Candidates of his or her choice. The ballots should reach me before June 28, 1999, so I can report the results of the election to the Chairman of the IUGS Commission on Stratigraphy not later than beginning of July. I apologize for such a tight schedule. I will very much appreciate your prompt action on this important matter. If possible I ask you to return your ballots by FAX or advance them by e-mail.

Appendix A to this Circular is a complete list of those ISSC members who returned the Nominating Form, and their nominations for Chairman and Vice Chairman of the Subcommittee.
